

To whom depart Japan for North Korea with currency and coins or other means of payment, etc exceeding 0.1 million JPY!

- How to fill in the “DECLARATION OF CARRYING OF MEANS OF PAYMENT, ETC.”

As from July 6, 2010, if you depart for North Korea with currency and coins or other means of payment exceeding 0.1 million JPY, you are required to declare to Customs. Please ask a Customs officer at seaport as well as airport for a blank form.

What you have to declare

◎ Following items in excess of 0.1 million JPY (or their equivalent):

- Currency and Coins (including foreign currency)
- Checks
- Travelers checks
- Promissory notes
- Securities

Place of destination or shipment

Please fill in your flight No. or name of vessel and place of destination of flight or vessel.

Expected date of export

If your scheduled date of departure is the day you submit declaration, please check “Day of declaration”. If your scheduled date of departure is the day after you submit declaration, please check “Day after declaration”.
