

4011 Elimination of Tariffs on Imported Goods under the Japan Chile
Economic Partnership Agreement

The Japan-Chile economic partnership agreement specifies details of tariff concessions in Annex 1. Immediate tariff elimination, gradual tariff elimination or reduction, and the categories for concession in tariff quota, etc., for Japan are prescribed in the "General Notes" of Part 1 of Annex 1 (Reference 1). Also, the detailed schedule for Japan on renegotiations, tariff quota and uniform tariff reduction, etc., are prescribed in "Notes for Schedule of Japan" in Part 2, Annex 1 (Reference 2).

1	Beef: Tariff quota requirements (quota: 1,300 tons in first year → 4,000 tons in fifth year; quota tax rate: 34.6% in the first and second years & 30.8% in the third through fifth years)
2	Pork: Tariff quota requirements (quota: 32,000 tons in first year → 60,000 tons in fifth year; quota tax rate: 2.2% in ad valorem duty for meat portions & 4.3% in ad valorem duty for processed meats)
3	Beef scraps: Tariff quota requirements (quota: 600 tons in first year, 750 tons in fifth year; quota tax rate: 11.5% in the first and second years & 7.6% in the third through fifth years)
4	Date of renegotiation (fifth year after EPA enforcement): Oranges, abalone, etc.
5	Chicken: Tariff quota requirements (quota: 3,500 tons in first year → 5,500 tons in fifth year; quota tax rate: 10.7% in the first and second years & 8.5% in the third through fifth years)
6	Date of renegotiation (3 years after EPA enforcement): Certain cheese products
7	Uniform tariff reduction: Waffles and wafers
8	Tomato purée and paste: Tariff quota requirements (quota: 3,700 tons in first year → 5,000 tons in fifth year; quota tax rate: Duty-free)
9	Uniform tariff reduction: Certain processed peanut products (with sugar added)
10	Uniform tariff reduction: Certain processed peanut products (others)
11	Uniform tariff reduction: Bottled wine
