INTERDICTIONS OF ILLICIT DRUGS AND FIREARMS SMUGGLING IN 2013

1. Number of Interdictions

(1) Summary

[The State of Seizures of Main Illicit Drugs and Firearms etc. in 2013]

The total number of seizures of illicit drugs *1 was 382 (up 24% year on year), and the quantity seized *2 was approximately 1,007 kg*3 (up 61% year on year). This was the first time in nine years, since 2004, that the seizure haul surpassed 1 ton.

Four firearm smuggling crimes were discovered (up 33% YOY), and the quantity seized was six firearms (up 50% YOY).

[Stimulant drug crimes]

The number of seizures was 154 (up 9% YOY), and the quantity seized was approximately 859 kg (up 78% YOY). This was the first time in 13 years, since 2000, that the seizure haul surpassed 800 kg.

There is a marked "trend to larger batches" in smuggling seizures.

- There were two cases of large-scale crimes in which approximately 200 kg were seized from marine cargo.
- The number of smuggling crimes with seizure quantities over 5 kg was substantially up, to 26 cases (up 53% YOY)

Seizures from air passengers reached a record level.

- The seizure quantity of approximately 304 kg was a new record, far surpassing the figure of approximately 235 kg for 2010.
- A majority of the seizure volume was concealed in modified souvenirs etc.

• Over 40% of the smugglers were in their 50s or older.

Smuggling source regions have **changed startlingly** in a short period.

- · Seizures from Africa and Europe, which were trending up in recent years, have declined.
- Seizures from Asia, particularly India and China, are surging.

[Cannabis crimes]

The number of seizures was 66 (down 20% YOY), and the quantity seized was approximately 13 kg (down 90% YOY).

Major reduction

[Narcotics crimes]

The number of seizures was 128 (up 2.8 times, YOY), and the quantity seized was approximately 135 kg (up 12.4 times, YOY).





2. Trends in Illicit Drug Smuggling

(1) Stimulants

- · Numerous large-scale stimulant smuggling crimes
- · Seizures of stimulants from air passengers reached a record level
- Smuggling from Asia surged, with levels from China and South and Central America remaining high

10,909 people were arrested for stimulant crimes, down somewhat year on year (-668 people, -5.8%). The number of people arrested for stimulant crimes has been in long-term decline since 1997, which was the third post-war peak in stimulant abuse, but it is still above 10,000.

Of those arrested for stimulant crimes, gang members etc. have numbered over 6,000 in recent years, but their number was down somewhat at 6,096 (-277, -4.3%). The number of foreigners also fell to 588 (-29, -4.7%) (National Policy Agency investigation).


The number of smuggling crimes detected by customs in 2013 was 154 (up 9% YOY), remaining at a high level with the third-highest figure, after 2011 and 2009. The seizure volume was approximately 859 kg (up 78% YOY), far surpassing the previous year's level to reach the third-highest volume. It was the first time in 13 years, since 2000, that seizures exceeded 800 kg. [See Chart 1]

The breakdown by type of smuggling shows a remarkable rise in detected cases of large-scale smuggling in commercial cargo and by air passengers. The seizure volume from commercial cargo rose sharply, to more than double the previous year's volume. The number of detected cases of smuggling by air passengers was 104 (up 24% YOY), and the seizure volume was approximately 304 kg (up 49% YOY). Both figures substantially surpassed the previous year's volume. In particular, seizure volume was a record, and the first time above 300 kg.

The breakdown by smuggling source region showed marked drops in the number of cases from Africa and Europe, but cases from Asia, and particularly from India, more than doubled from the previous year, in a major increase. Detected smuggling cases from Mexico and China remained at high levels.

(2) Cannabis (herbal cannabis and cannabis resin (hashish))

· Reductions in both number of detections and seizure volume

Over the last ten years, the number of people arrested for cannabis crimes peaked in 2009 and has been declining since then, to reach 1,555 people (-48 people, -3.0% YOY) in 2013. Of those, 467 were gang members etc. (-95 people, -16.9%), and 94 were foreigners (-16 people, -14.5%) (National Police Agency investigation).

The number of smuggling crimes detected by customs in 2013 was 66 (down 20% YOY), and the quantity seized was approximately 13kg (down 90% YOY) [See Chart 2].



(3) Other Illicit Drugs (cocaine, heroin,α-PVP)

Number of interdictions


[1] The number of cocaine smuggling crimes detected by customs in 2013 was 10 (up 43% YOY), and the quantity seized was approximately 127 kg (up 13.5 times, YOY) [See Chart 3].

[2] The number of heroin smuggling crimes detected by customs in 2013 was 3 (100% YOY), and the quantity seized was approximately 4 kg (up 3.7 times, YOY) [See Chart 4].

[3] In 2013, customs detected 88 cases of smuggling "α-PVP", which has been newly designated as a narcotic. This large number of cases accounted for around 7 in 10 of the total number of narcotics crimes (128 cases).

3. Trends in Firearms Smuggling

The number of handguns seized, including those seized from gangs, is on a long-term downward trend, but increased to 471 guns (+98 guns, +26.3% YOY) in 2013. Of those, 332 guns were genuine handguns (of which 13 were smuggled) (+23 guns, +7.4%), and 139 were replicas (+75 guns, +117.2%) (National Police Agency investigation). Four firearm smuggling crimes were discovered in 2013 (up 33% YOY), and the quantity seized was 6 firearms (up 50% YOY) [See Chart 5].
