Annex 2 referred to in Chapter 3 Product Specific Rules

Part 1 General Notes

For the purposes of the product specific rules set out in this Annex:

- (a) the product specific rule, or specific set of rules, that applies to a particular heading or subheading is set out immediately adjacent to the heading or subheading;
- (b) reference to weight in this Annex means dry weight unless otherwise specified in the Harmonized System;
- (c) the following definitions apply:
 - (i) the term "section" means a section of the Harmonized System;
 - (ii) the term "chapter" means a chapter of the Harmonized System;
 - (iii) the term "heading" means the first four digits in the tariff classification number under the Harmonized System; and
 - (iv) the term "subheading" means the first six digits in the tariff classification number under the Harmonized System;
- (d) where a specific rule of origin is defined using the criterion of a change in tariff classification (hereinafter referred to in this Annex as "CTC"), as set out in subparagraphs (e)(i) through (iii), each of the non-originating materials used in the production of the good shall be required to undergo the applicable CTC. A requirement of a CTC shall apply only to nonoriginating materials;
- (e) the following abbreviations apply:
 - (i) the term "CC" denotes a change to the chapter, heading or subheading from any other chapter. This means that all nonoriginating materials used in the production of the good have undergone a CTC at the two-digit level (i.e. a change in chapter) of the Harmonized System;
 - (ii) the term "CTH" denotes a change to the chapter, heading or subheading from any other heading. This means that all nonoriginating materials used in the production of the good have undergone a CTC at the four-digit level (i.e. a change in heading) of the Harmonized System;

- (iii) the term "CTSH" denotes a change to the chapter, heading or subheading from any other subheading. This means that all non-originating materials used in the production of the good have undergone a CTC at the six-digit level (i.e. a change in subheading) of the Harmonized System; and
- (iv) the term "QVC 40" or "QVC 50" respectively means that the good has a qualifying value content, calculated using the formula set out in subparagraph 4(b) of Article 29, of not less than 40 percent or 50 percent, and the final process of production has been performed in a Party;
- (f) this Annex is based on the Harmonized System as amended on January 1, 2017 (hereinafter referred to in this Annex as "HS2017");
- (g) specific percentages referred to in Article 31, which relate to the total value or the total weight of non-originating materials used in the production of a good that do not undergo an applicable change in tariff classification, are as follows:
 - (i) in the case of a good provided for in chapters 28 through 49 and 64 through 97 of the Harmonized System, 10 percent in value of the good; and
 - (ii) in the case of a good provided for in chapters 50 through 63 of the Harmonized System, seven percent by weight of the good;
 - Note 1: The term "value of non-originating materials" means the value determined in accordance with paragraph 6 of Article 29.
 - Note 2: The term "value of the good" means the free-on-board value of the good referred to in subparagraph 4(b) of Article 29 or the value set out in paragraph 5 of that Article.
- (h) For the purposes of chapters 28 through 40 of the Harmonized System:
 - (i) the term "chemical reaction" means a process, including a biochemical process, which results in a molecule with a new structure by breaking intramolecular bonds and by forming new intramolecular bonds, or by altering the spatial arrangement of atoms in a molecule, but does not include:
 - (A) dissolving in water or other solvents;
 - (B) the elimination of solvents including solvents water; or
 - (C) the addition or elimination of water of crystallization;

- (ii) the term "purification" means a process of reduction or elimination of impurities resulting in:
 - (A) the elimination of not less than 80 percent of the content of existing impurities; or
 - (B) a good directly suitable for one or more of the following applications:
 - (AA) pharmaceutical, medical, cosmetic, veterinary or food grade substances;
 - (BB) chemical products and reagents for analytical, diagnostic or laboratory use;
 - (CC) elements and components for use in microelectronics;
 - (DD) specialized optical use;
 - (EE) biotechnical use;
 - (FF) carriers used in a separation process; or
 - (GG) nuclear grade use;
- (iii) the term "isomer separation" means a process of isolation or separation of an isomer from a mixture of isomers; and
- (iv) the term "biotechnological processes" means:
 - (A) biological or biotechnological culturing, hybridization or genetic modification of micro-organisms or cells of human, animal or plant; or
 - (B) production, isolation or purification of cellular or intercellular structures;
- (i) For the purposes of chapters 50 through 55 and 60 of the Harmonized System, dyeing or printing process shall be accompanied by two or more of the following operations:
 - (1) antibacterial finish;
 - (2) antimelt finish;

- (ii) For the purposes of headings 50.07, 51.11 through 51.13, 52.04 through 52.12, 53.09 through 53.11, 54.07, 54.08, 55.08 through 55.16, 56.04 through 56.09, 59.02, 59.10, chapters 57, 58 and 60 through 63, a non-originating material which is carded or combed, spun, dyed or printed, woven, or knitted or crocheted entirely in the other Party or a non-Party which is a member country of the ASEAN shall be transported to the Party where the non-originating material is used for the production of a good:
 - (A) directly from that other Party or that non-Party; or
 - (B) through one or more non-Parties for the purpose of transit or temporary storage in warehouses in such non-Parties, provided that it does not undergo operations other than unloading, reloading or any other operation to preserve it in good condition; and
- (iii) For the purposes of determining the origin of a good of chapters 61 through 63, the rule applicable to that good shall only apply to the component that determines the tariff classification of the good and such component must satisfy the tariff change requirements set out in the rule for that good; and
- (i) a good which is covered by Attachment A or B of the Ministerial Declaration on Trade in Information Technology Products adopted in the Ministerial Conference of the World Trade Organization on December 13, 1996 and is used as a material in the production of another good in a Party may be considered as an originating material of the Party, regardless of the applicable product specific rule for the former good, provided that the former good is assembled in either Party; and
 - (ii) subparagraph (i) shall not apply to a good which is classified in subheading 8541.10 through 8542.90.
